Terms of Use

These Terms of Use are a legal agreement between you and Your Yume. By downloading, accessing, or using the app or website, you agree to these Terms. If you do not agree, do not use Your Yume.

1. The Service

Your Yume provides tools for creating character, relationship, and template pages. Features may include editable templates, image slots, color controls, selectors, premium templates, ads for free users, and other creative tools.

2. Eligibility

You must be at least 13 years old to use Your Yume. If you are under the age of majority where you live, you may use the app only with permission from a parent or legal guardian. You may not use the app if you are barred from doing so under applicable law.

3. Your Content

You keep ownership of the text, photos, names, notes, and other content you add to Your Yume. You are responsible for your content and for making sure you have the rights needed to use it. Do not upload, save, share, or create content that violates another person's rights or applicable law.

4. License You Give Us

When a feature requires us or our service providers to process your content, you grant us a limited license to host, copy, display, process, and transmit that content only as needed to provide, maintain, secure, and improve that feature. Content stored only on your device is not licensed to us except to the extent your device or app needs to display and operate it.

5. Acceptable Use

You agree not to:

- Use the app for unlawful, abusive, harassing, exploitative, or harmful activity.
- Infringe copyrights, trademarks, privacy rights, publicity rights, or other rights.
- Attempt to reverse engineer, disrupt, overload, or interfere with the app or its services.
- Bypass purchase, subscription, entitlement, ad, or security systems.
- Use automated tools to scrape, copy, or misuse the app or website.

6. Premium Features, Purchases, and Refunds

Some features may require a paid purchase or subscription. Purchases made through the iOS app are processed by Apple and are subject to Apple's payment terms. Prices, product names, and feature availability may change. Refund requests for App Store purchases are handled by Apple unless applicable law requires otherwise.

7. Ads

Free users may see ads. Premium or lifetime users may receive ad-free access where that benefit is included in the purchase. Ads should not block core functionality if they fail to load, and we may adjust ad formats, placement, and frequency over time.

Apple and its subsidiaries are third-party beneficiaries of these Terms for purposes of enforcing them against you.

9. Intellectual Property

The app, website, logo, design, templates, software, and related materials are owned by us or our licensors and are protected by intellectual property laws. These Terms do not transfer ownership of our intellectual property to you. You may use the app only as permitted by these Terms.

10. Third-Party Services

Your Yume may rely on third-party services such as Apple, RevenueCat, Google AdMob, hosting providers, and other tools. Their services may be governed by their own terms and policies. We are not responsible for third-party services we do not control.

11. No Professional Advice

Your Yume is a creative tool. It does not provide legal, financial, medical, mental health, safety, or other professional advice. You are responsible for how you use the app and any content you create with it.

12. Changes and Availability

We may modify, suspend, or discontinue any part of the app or website at any time. We may also update these Terms. The updated Terms will be posted on this page with a new "Last updated" date. Continued use after changes means you accept the updated Terms.

13. Termination

We may suspend or terminate access to the app or services if we believe you violated these Terms, created legal risk, or used the app in a way that could harm users, us, or third parties. You may stop using the app at any time.

14. Disclaimers

The app and website are provided "as is" and "as available." To the maximum extent permitted by law, we disclaim all warranties, express or implied, including warranties of merchantability, fitness for a particular purpose, non-infringement, availability, and error-free operation.

15. Limitation of Liability

17. Governing Law

These Terms are governed by the laws of the United States and the state where the app operator is located, without regard to conflict-of-law rules, unless applicable law requires a different governing law.
